WestWind Employee Agreement

This Agreement is made and entered into this day of _____, 20____ by and between _____ (hereinafter referred to as "EMPLOYEE/CONTRACTOR") and *WestWind Engineering, Inc.* (hereinafter referred to as "*WestWind*").

WHEREAS, *WestWind* desires to employ EMPLOYEE/CONTRACTOR for technical assistance work to be performed for various companies (hereinafter called "CLIENT"); and

WHEREAS, EMPLOYEE/CONTRACTOR is qualified for such technical work and will be employed by *WestWind* hereunder;

NOW THEREFORE *WestWind* and EMPLOYEE/CONTRACTOR agree as follows:

1. EMPLOYEE/CONTRACTOR shall begin work on a mutually agreed upon date.
2. EMPLOYEE/CONTRACTOR understands that he or she is employed on a per-hour basis. *WestWind* will pay EMPLOYEE/CONTRACTOR at an agreed upon rate per hour, effective on the day that EMPLOYEE/CONTRACTOR begins work. EMPLOYEE/CONTRACTOR agrees that time records of *WestWind* or CLIENT shall be conclusive as to the time worked by EMPLOYEE/CONTRACTOR.
3. During the term of this agreement *WestWind*, CLIENT and EMPLOYEE/CONTRACTOR may exchange technical information and data as reasonably required for each to perform its obligations hereunder. Proprietary information made available or generated in written form by the parties shall be marked with the legend "PROPRIETARY INFORMATION" or an equivalent conspicuous legend (hereinafter Proprietary Information). EMPLOYEE/CONTRACTOR as a recipient of information hereunder agrees to keep in confidence and prevent any disclosure to any person or persons outside *WestWind* or CLIENT's organization or any unauthorized person or persons within *WestWind* or CLIENT's organization all Proprietary Information received under this agreement.
4. Either party may declare this Agreement terminated by written notice to the other party.
5. This contract shall be interpreted and the rights, duties and obligations of the parties determined by the laws of the state of California. Any litigation that may result with respect to this contract shall be limited to the United States Federal Courts of California, or if no jurisdiction exists thereto, then to the State Courts of California.
6. This Agreement constitutes the entire understanding and agreement of and between the parties with respect to the subject matter hereof, and supersedes all prior representations and agreements verbal or written.
